The last day of filing is Monday, March 14, 2022 and our office will be open until 5:00 p.m. Those nominating petitions received after 8:30 a.m. and before 4:30 p.m. during the filing period will be stamped according to the time received. Petitions received prior to the first day and after the last day of filing will be returned to the prospective candidate.

### SIGNATURE REQUIREMENTS

**Established Party:** At least 0.5% (.005) of the vote cast for any candidate of the party who received the highest number of votes in the county at the last General Election. The highest vote getter could be any federal, state, or county candidate. For 2022 only, this signature requirement shall be reduced by one-third. (10 ILCS 5/2A-1.1b(b), 7-10(c))

Independent: Not less than 5% nor more than 8% (or 50 more than the minimum, whichever is greater) of the total number of persons who voted at the last General Election in the county. (10 ILCS 5/10-3) New Party: Not less than 5% of the number of persons who voted at the last General Election in the county, except that where 5% is greater than 25,000, the minimum number of signatures required is 25,000. (10 ILCS 5/10-2)

For specific signature calculations, contact the county clerk.

# **FILING INFORMATION**

**Established Party:** Not more than 113 nor less than 106 days prior to the General Primary. (10 ILCS 5/7-12)

**Independent & New Party:** For 2022 only, July 5, 2022 – July 11, 2022. (10 ILCS 5/2A-1.1b(m))

Candidates will file in the office of the county clerk. Candidates in Peoria County file with the Peoria County Board of Election Commissioners.
