Petitions received prior to the first day and after the last day of filing will be returned to the prospective candidate.

(10 ILCS 5/ 7-10(c)) Independent: Not less than 5% nor more than 8% (or 50 more than the minimum, whichever is greater) of the total number of persons who voted at the last general election in the county. (10 ILCS 5/10-3) New Party: Not less than 5% of the number of persons who voted at the last general election in the county, except that where 5% is greater than 25,000, the minimum number of signatures required is 25,000. (10 ILCS 5/10-2)

Established Party: Not more than 141 nor less than 134 days prior to the General Primary. (10 ILCS 5/7-12)
