

### CUNNINGHAM AND RICKERT TAKE THE INITIATIVE TO INCREASE DELIQUENT TAX COLLECTION

Illinois State Statute requires tax buyers to send out a take notice within four and one half months of the tax sale. Depending on when the tax buyers choose to do so, property owners may not know that their taxes were sold until they receive the take notice. County Clerk ,John Cunningham and County Treasurer, David Rickert decided property owners need to know as soon as possible that their taxes were sold. So beginning last year, the clerk and the treasurer mailed out a courtesy letter a week after the tax sale letting property owners that their taxes were sold at tax sale and to contact the County Clerk for instructions on how to redeem the taxes.

The result of this letter has been more than worthwhile. The delinquent tax collection for the month of November in 2013 and 2014 increased redemptions by 40% from prior years. This year 503 parcels redeemed, reducing the outstanding redemption amount due to the county by \$2.1 million dollars, leaving 2617 parcels and \$16.3 million dollars as yet unredeemed.

Many of the property owners did not realize that their property taxes went unpaid.

The Clerk and the Treasurer intend to continue this practice of more open and helpful communication in future years.

#### **LEVIES**


District **LEVIES** must be filed on or before the last Tuesday of December with the Kane County Clerk's Office. Accompanying the levy must be a Certificate of Levy and a Truth in Taxation Certificate. All documents must have original signatures notarized or sealed with the districts' seal. Failure to do so could mean a loss of tax dollars.

Average turn around time for a passport is 4 to 6 weeks. You may expedite for an extra charge bringing the turn around time to 3 weeks.

#### **News From the 2014 General Election:**

New legislative changes were successfully implemented from an operational perspective for the November General Election. It generated a 48% voter turnout. Many Kane County voters utilized the new extended grace period registration and voting at permanent early voting sites.

#### **News From the 2015 Consolidated Election:**

The Kane County Clerk's Elections Department continues to work towards the April Consolidated Election. In preparation for the upcoming April 7, 2015 Election, The Election Department has set procedures in place for the additional filings of School District Candidates and Trustees in addition to the Regional School Districts.

#### BE PREPARED! REGISTER TO VOTE

A person can register to vote by mail or in person. You must provide 2 acceptable forms of ID when registering. Registering by mail requires the completion of the mail in registration form provided on the Kane County Clerk's web page and two acceptable forms of ID.

Information on Acceptable forms of ID's (Public Act 83-0258) can be found on our website, www.kanecountyelections.org.

To be eligible to vote you must be a US citizen, 18 years old by the next election, and have resided in the precinct for 30 days prior to the next election.

Voters who have changed their name since registering to vote must re-register to vote. Grace Period registration is for persons who missed the deadline to register to vote During Grace Period registration you may register to vote at the Kane County Clerk's office from the 27th day through the 3rd day prior to the election. If you register to vote during grace period and want to vote in the upcoming election, you MUST vote at the time of registration.
