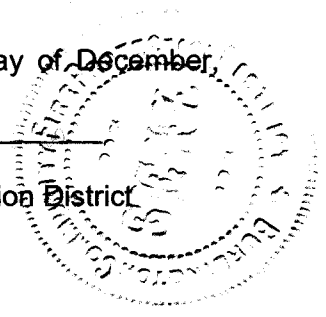
**ORDINANCE LEVYING AND ASSESSING TAXES OF

**ORDINANCE NO. 2013-05**

**ORDINANCE LEVYING AND ASSESSING TAXES OF  
BURLINGTON COMMUNITY FIRE PROTECTION  
DISTRICT, KANE AND DE KALB COUNTY FOR 2013**

**WHEREAS**, the Burlington Community Fire Protection District has the authority to levy for taxes; and

**WHEREAS**, the Board of Trustees of the Burlington Community Fire Protection District, on December 19, 2013, held a public hearing on its proposed 2013 tax levy as required by the Truth in Taxation Law.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Burlington Community Fire Protection District as follows:

**Section One:** That the sum of Seven Hundred Thousand and no/100 (\$700,000.00) Dollars be assessed and levied from and against all taxable property within the limits of the Burlington Community Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2013. The specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount To Be Raised By Tax Levy" as follows:

**CORPORATE FUND**

**AMOUNT TO BE RAISED BY TAX LEVY:**

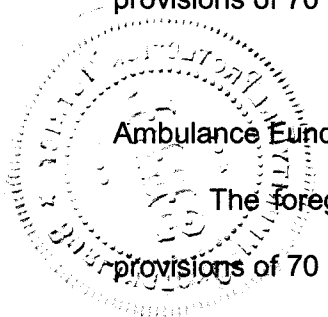
Corporate Fund Levy	\$350,000.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

**AMBULANCE FUND**

Ambulance Fund Levy	\$350,000.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to provisions of 70 ILCS 705/22.

**Section Two:** That the Secretary is hereby directed to file a certified copy of this Ordinance with the Clerks of DeKalb County and Kane County within the time specified by law.

**Section Three:** If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of this Ordinance.

**Section Four:** That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
